\$2,000,000 Annual Liability Insurance Limit

NO LIMIT Defense Expenses

Defense expenses incurred in the defense of a civil or criminal proceeding or investigation are paid in addition to the limit of liability for covered occurrences.

\$250,000 Cost of Bail Expense Limit

A \$2,500,000 bail bond typically costs \$250,000 or 10% of the set bail. You'll have \$250,000 of funds available for bail expenses, including cash bail or the cost of a bail bond and monitoring expenses.

\$20,000 Incidental Expense Limit

Up to \$20,000 for Incidental Expenses related to a covered incident, such as the cost to replace a confiscated firearm, and Additional Living Expenses.

\$10,000 for Loss of Earnings

Up to \$10,000 for actual loss of earnings for time taken off within 30 days of an incident. This is in addition to the up to \$750/day for loss of earnings due to missing work due to your covered case.
